I/We D Suresh, age 70 years, Chairman of Vidya Samskruthi School register with Karnataka Government Trust Act running Vidya Samskruthi School. 611, 16th cross road, G.D.Park, Vyalikaval, Bnagalore-560003, do hereby solemnly affirm and sincerely state as follows:

- 1. The Vidya Samskruthi School is a registered society/Trust under the Karnataka Government Trust Act Reg. Sl.No.63/76-77
- 2. That the Vidya Samskruthi School (Reg.Sl.No. 63/76-77, dated. 11-06-1976 registered with Karnataka Government Trust Act) is of Non-Proprietary Character.
- 3. That the School is being run as a Community service and not as a business and that Commercialization does not take place in the school in any manner whatsoever.
- 4. That no part of income from the institute is being and will be diverted to any individual in the Trust/Society/Company/School Management committee or to any other Person/entity. The saving, if any, after meeting the recurring and nonrecurring expenditure and contributions to developmental, Depreciation and Contingency funds, will be further utilized for promoting the School and extending the cause of education in the same School only.
- 5. That School is not paying any charges towards using name, motto, logo or any other non-Academic activities to any other institution, organization or body.
- 6. That the School will not open classes under CBSE pattern particularly class IX/X/XII/XII and will not use CBSE name in any manner without obtaining affiliation.
- 7. That the Principal and Correspondent/Manager of the School have individually gone through the provisions contained in the affiliation & examination by elaws and the circulars issued by the board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the time and the law of the land.
- 8. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour laws etc. with respect to the school and staff of the school.
- 9. That the school will ensure that the building safety, Water Safety, Health and Hygiene certificate are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.

- 10. That the school will ensure that all required infrastructure is available with the school before starting classes.
- 11. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation by bye-laws are available with the school before starting classes.
- 12. That the school will follow the provisions related to fee contained in affiliation byelaws and will disclose the details of the fee to the students or parents every year before start of session without resorting to any hidden charges in the heads of the fee.
- 13. That the school will not force any student or parents to buy books or stationary or uniform from any particular shop.
- 14. That the school shall strive to make efforts for conservation of environment.
- 15. That the school will ensure that the school fulfills all essential requirement before applying for affiliation and will fulfill all other conditions post affiliation and comply with all the general rules as give in the affiliation byelaws or notified from time to time.
- 16. That the school will not start CBSE pattern classes without submitting commencement certificate to the effect that the school has compiled with all the conditions In post by CBSE and the post affiliation conditions contained in affiliation byelaws along with general rules.
 (In case of schools application is under switchover category please include the following clause in the Affidavit).
- 17. That state pattern classes IX –XII running prior to the affiliation to CBSE would be sponsored for the state board examination. State pattern classes IX-XII will be closed in a phased manner. No admission will be taken in the state board pattern class IX-XII after getting affiliation from CBSE. The state board school will be discontinued after switching over to CBSE.
